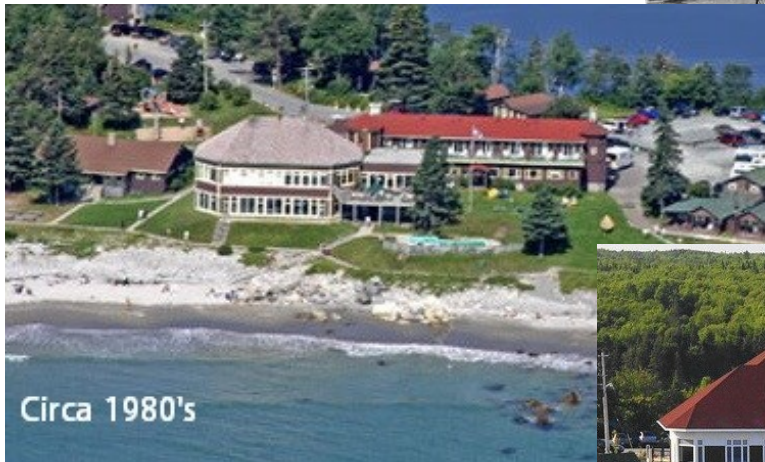

PRESIDENT'S REPORT

H. James McIntosh, P.Eng., NSLS, CLS



Since my last report in May, I have attended provincial AGM's in Newfoundland, Saskatchewan and Manitoba, while Vice-President Kevin Brown represented us in Quebec.

The main issue in Newfoundland, was a motion to make participation in the Land Gazette mandatory for all practicing NLS's. The Land Gazette is a graphic index of surveyed parcels, developed by a private firm whereby surveyors can access indexed plans for a fee, paid to the submitting surveyor. In support of the argument that not enough members were using the system to maintain it, membership voted in favour of compulsory participation.

Saskatchewan votes each year on whether to continue as an "all in" member of Professional Surveyors Canada (PSC). Concerns were raised regarding PSC's application for a trademark on the designation P.Surv. for national use without consultation with SLISA, who uses that designation for their members involved in non-legal surveying activities. Despite the concern, Saskatchewan voted to remain as an "all in" province within PSC.

Like us, Manitoba is in the process of updating their governance documents. This year they approved bylaws by passing 32 motions and 3 resolutions in 1 busy day. The next step will be to review Standards and establish a process for Survey Review. This is now understood to be a critical component of self-regulating professions, given recent decisions to take that responsibility away from Realtors in BC and Engineers in Quebec.

When I took over as President a year ago, I identified 4 primary issues that I thought Council would need to address: Registry Privatization, Act Enforcement, implementation of NAD83 and ongoing Standards Review.

Regarding **Registry Privatization**, a collective sigh of relief was heard in March when the Province announced that it would continue to maintain our land registration system internally.

We sent letters of thanks to the Premier and Minister of Service Nova Scotia, offering our assistance going forward as major stakeholders in the system.

Myself, Fred Hutchinson, Paul Harvey and Bruce MacQuarrie had met with the Registrar General and Property Mapping Manager in December, 2015, to discuss how we could submit our plans for registration in pdf, and eventually vector formats. This has been very well received as we expect a large increase in the number of plans being submitted, after we voted in favour of compulsory registration of retracement plans last October.

Since then, we met again in June and September to keep the momentum going and have used that opportunity to discuss a number of surveying issues that have arisen through the process of migrating old land registry parcels into the new land titles system. I appreciate and consider this ongoing communication with Service Nova Scotia as a significant accomplishment going forward.

Regarding **Act Enforcement**, the particular issue this year concerns the new On-site Sewage Disposal System Regulations and Standards (OSSDS), which came into effect last May. As previously reported, I sent a letter to NS Environment in March, pointing out at least 5 ways in which those Regulations potentially require Qualified Persons to practice professional land surveying. To date we've received no response, other than an email stating they would need some time to discuss.

In the meantime, Council approved Terms of Reference to create the new NS Environment Liaison Committee, consisting of members who are

all QPs under the Chair of Past President Cyril LeBlanc. The goal is to establish a line of communication between our Association, NS Environment, Wastewater NS, and Engineers NS, so we can all work together to resolve these particular issues and hopefully be at the table to discuss future revisions.

To that end, I have recently sent a follow-up letter to NS Environment expressing our disappointment with the lack of communication and a suggestion of our obligation to further pursue these issues if not addressed through our Committee.

Regarding **NAD83** and the **Active Control Network**, serious congratulations are in order to Dr Jason Bond, who has almost single handedly been responsible for getting this state of the art system up and running for us here in Nova Scotia. Congratulations are also in order, to Jason, Jody Isenor, Fred Hutchinson and all the other presenters and participants in the 2-day seminar held in Truro in August. I was not able to attend, but all reports I've received were that it was a great success.

Our new **Standards** came into effect in January, which completed an almost 10-year process to modernize our Governance documents. Now Bylaws and Standards, in particular, can be changed by resolution or motion approved by our membership. I'm pleased to report that Ray Pottier has agreed to take over as the Chair of our ongoing Governance & Standards Committee.

And of course, many other issues arise during the year which require Council's attention. This year, we dealt with Committee appointments, Committee updates, Zone meeting updates, financial status, investments, budget, membership, candidate articles, website, CBEPS, PSC, complaints appeal, Continuing Professional Development (CPD), CPD Evaluation & Non-Compliance, Survey Review Department, Foreign Credential Recognition, Legislative Review, File Retention, COGS Awards, President's Travel, AGM, etc, etc. Most of these are managed by our various committees to whom I send out a huge thank you on behalf of the membership

for volunteering your time to the continuing successful operation of our Association.

My term as President has been an extremely rewarding and learning experience, that I highly recommend to all of our interested members. Perhaps the biggest thing I've learned, is that although survey and land registration systems vary greatly across Canada, the issues that all our Provincial associations are dealing with, are surprisingly similar: financial sustainability, membership sustainability, changing technology, changing profession, relevance, self-governance and public awareness.

In our case, my biggest take away is our need to improve our relationship and communication with government. On the topic of Registry Privatization, there was no consultation from Service NS, or even a recognition that we were significant stakeholders. On the topic of OSSDS Regulations, there was no consultation, or even a response to our concerns about their conflict with the Land Surveyors Act. On the topic of Municipal Subdivision Bylaw revisions (in HRM at least), there was no consultation, or even notification that changes were made that directly affect our knowledge of the rules and ability to provide our services to the public.

It's painfully clear, that in these three particular cases, and I'm sure there are more, government somehow feels that we don't add value to the discussion. That's why I'm pushing for committees to communicate with Service NS, NS Environment, HRM, and anyone else who can benefit from our knowledge and experience. Hopefully the small steps we've taken so far will be the start of improving long term relationships with these and other organizations in the future.

Finally, a big thank you to the membership for allow-ing me to serve, Council for your assistance with making the necessary decisions, and Association staff for so competently managing the tedious day-to-day operation of our organization. It has been an honour to represent such a supportive and professional group of individuals.



EXECUTIVE DIRECTOR'S REPORT

This year we did not meet our publication deadline prior to the annual general meeting held at White Point Beach Resort. It just seemed like we encountered several roadblocks but we did manage to send out a preliminary draft by email before the meeting highlighting

new Council members, Peter Berrigan, zone 1, Joe Harvie, zone 4 and Ken Cormier as vice-president. The draft copy also illustrated the motions that would be presented under “new business”.

I am pleased to state that all motions were approved unanimously. The business meeting was followed on Saturday by a seminar. This full day dealt with three presentations. The first illustrating a boundary conflict presented by Peter Berrigan and Arthur Backman labelled “The Tale of Two Neighbours”. The second presentation was about the replacement of the bridge decking on the Angus L. MacDonald Bridge titled “The Big Lift”. The afternoon session was titled “Water Bounds in Nova Scotia” and presented by Dr. Brian Ballantyne.

All three sessions were video recorded and will be made available for viewing once editing has been completed. The August seminar was also recorded and should also be available online soon. All presentations will have CPD credits available as well as being a great way to review the material for those who attended.

Next year, July 1, 2017 is the 150th birthday of Canada. The Associations of Ontario Land Surveyors, Ordre des arpenteurs-géomètres du Québec and Association Canada Lands Surveyors have organized a first-ever joint meeting in Ottawa for March 1-2, 2017. All Canadian land surveyors are invited and you can view the agenda by visiting www.surveyors2017.ca.

Even though July 1 will have passed by the time of our AGM in October, we Bluenosers do not want to miss out on celebrating such an event. We have booked Fox Harb’r Resort as the location for our 67th annual meeting.

COMMITTEE REPORTS

October 14, 2016

Complaints Committee

As of the end of June, there were six complaints being investigated:

1. One complaint relates to a land claim and charges misconduct based on the Surveyor's depiction on the plan.
2. Two accuse misconduct based on the Surveyor's indication of adjacent boundary lines on the plans.
3. Another charges misconduct based on a breach of our code of ethics.
4. One misconduct complaint arises from an incomplete survey.
5. Finally, a charge of misconduct based on incompetence and a breach of our code of ethics.

One complaint has recently been dismissed, however the Committee has received three new complaints in September, thereby totalling eight complaints to be addressed at our next meeting on October 24th.

The committee is populated by: Brian Spicer as the public representative, Arthur Backman, Joseph Harvey, Gary Parker, Alan Gallant as vice chairman and Glenn Crews as chairman.

Board of Examiners Committee

I would like to note that the following individuals have qualified as Nova Scotia Land Surveyors in the past year: Conor McGuire (NSLS # 659), Wesley McNeil (NSLS # 660), David Umlah (NSLS # 661) and Darren Trevors (NSLS # 662).

The Board of examiners reports that we presently have 27 candidate members, with only about four who have not been very active in the pursuit of a commission. It should be noted that while most candidates enter the system with a degree in survey science and a CBEPS

certificate, about half are getting their commission through home study. Darren Trevors, as mentioned earlier, has completed the entire CBEPS syllabus through home study. That is approximately 17 difficult exams to prepare for, write and pass. Way to go Darren!

CBEPS has been appointed by Council to oversee academic accreditation for candidates. These candidates still need to write a Nova Scotia jurisdictional exam, complete a project and serve a period of articles. As a point of interest, the last 20 newest members, seven have been labour mobility candidates from other provinces.

I would like to take a moment to thank Joe Harvie, who is now stepping down as our representative on the CBEPS Board of Directors, after having served for the past 9 years.

Two candidates presently have their survey projects under review, which is the last hurdle that remains for them to get their licence. We have four candidates who have been assigned a survey project and three more candidates waiting for one to be assigned. Projects are always of a "not for profit" parcel, or parcels of land, such as a community centre, park, church or cemetery. The Board welcomes any suggestions that members may have for such projects. Special thanks to Nick Dearman and the many members of the special examining group who review projects and interview the candidates within 30 days of their submission. If any member would like to be a reviewer, please contact Nick or the Association office to volunteer.

Our secretary to the Board, Fred Hutchinson, informs me that 46 members have obtained their commission in the past 17 years since he has served as secretary, which is about one third of our active membership. I would like to thank Fred, and the other members of the Board of Examiners, who have assisted in this activity namely, Ernie Blackburn, Kevin Brown, John MacInnis, George Sellers and yours truly, Kevin Robb.



NOTES TO UNAUDITED FINANCIAL STATEMENTS

FOR THE YEAR ENDED DECEMBER 31, 2015

The Association of Nova Scotia Land Surveyors (the "Association") was incorporated as a professional organization under the Land Surveyors Act of Nova Scotia to establish and maintain standards of the profession.

1. SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements were prepared in accordance with Canadian Accounting Standards for Not-for-Profit Organizations (ASNFPPO) and include the following significant accounting policies:

Financial Instruments

The financial assets and liabilities are initially recorded at fair value. The Association subsequently measures all financial assets and liabilities at cost or amortized cost. Changes in fair value are recognized in net income.

Financial assets measured at cost include cash and accounts receivable. Financial liabilities measured at cost include accounts payable and amounts owing to government.

Cash

The Association defines cash as the amount of cash on hand and cash on deposit net of cheques that are issued and outstanding at the end of the year.

Building

The building is recorded at cost. Amortization is calculated using the declining balance method at an annual rate of 4%.

In the year of acquisition, amortization is calculated at one-half of the annual rate.

Impairment of Long-lived Assets

Property subject to amortization is tested for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. An impairment loss is recognized when the carrying amount of the asset exceeds the sum of the projected future net cash flows resulting from its use and eventual disposition. The impairment loss, if any is measured as the amount by which the carrying amount of the asset exceeds its fair value.

Income Taxes

The Association is a not-for-profit organization, as described in Section 149(1)(1) of the *Income Tax Act*, and is therefore exempt from income taxes.

Revenue Recognition

Revenue is recorded in the period that is due and collectible. Revenue and expenditures are recorded using the accrual basis of accounting.

1. SIGNIFICANT ACCOUNTING POLICIES . . . (continued)

Contributed Services

The Association would not be able to carry out its activities without the services of the many volunteers who donate a considerable number of hours. Because of the difficulty of determining the fair value, contributed services are not recognized in the financial statements.

Statement of Cash Flows

The Association prepares the statement of cash flows on a net cash basis and reports cash flows from operating activities using the indirect method.

Use of Estimates

The preparation of financial statements in accordance with Canadian accounting standards for not-for-profit organizations requires management to make estimates and assumptions that affect the reported amount of assets and liabilities, the disclosure of contingent assets and liabilities as at December 31, 2015 and the reported amount of revenue and expenses for the year then ended. These estimates are reviewed periodically, and as adjustments become necessary, they are reported in earnings in the year in which they become known.

2. FINANCIAL INSTRUMENTS AND RISK MANAGEMENT

The significant financial risks to which the Association is exposed are credit risk, interest rate risk, and liquidity risk.

Credit Risk

Financial instruments that potentially subject the Association to credit risk consist of cash and accounts receivable. The Association uses reputable institutions for cash and believes risk of loss to be remote. The association estimates an allowance for doubtful accounts for accounts receivable. As at December 31, 2015 and December 31, 2014 no allowance for doubtful accounts for accounts receivable was recorded. Any credit losses are provided for in the financial statements and consistently have been within management's expectations.

Interest Rate Risk

Interest rate risk is the risk that the fair value of future cash flows of a financial instrument will fluctuate because of changes in market interest rates. Changes in the bank's prime lending rate can cause fluctuations in interest payments and cash flows. The Association does not use derivative financial instruments to alter the effects of this risk.

Liquidity Risk

Liquidity risk is the risk the Association will encounter difficulty in meeting obligations associated with financial liabilities. The Association is exposed to liquidity risk arising primarily from the accounts payable and amounts due to the government. The Association's approach to managing liquidity risk is to ensure that it always has sufficient cash flows and cash on hand to meet its operating obligations.

3. RELATED PARTY TRANSACTIONS

During the year the Association received rental income of \$4,800 (2014 - \$4,800) from the Executive Director. The rent income was earned in the normal course of operations under the same terms and conditions as transactions with unrelated third parties. As at December 31, 2015 there is a balance of \$2,000, (2014 - \$2,000) in accounts receivable as a result of these transactions.

10. Building maintenance is comprised of major expenses to repair and/or maintain the association office building.
11. Annual building depreciation.
